Campaign Updates

Right to Housing Forum

On June 27, 2018, more than 150 advocates, attorneys, currently and formerly homeless individuals, funders, and government representatives, from over 100 organizations and 30 states gathered in Washington, D.C. for the annual National Forum on the Human Right to Housing organized by the **National Law Center on Homelessness & Poverty**. This year, the Forum's focus was on the Housing Not Handcuffs Campaign, to strategically advance our collective work *against* criminalization of homelessness and *for* housing. The Forum was designed to draw on the resources that each participant brought to the table and to help create new ones. The event provided the opportunity to share victories and challenges and strategize for future advocacy, particularly around issues with panhandling, encampments, renter's rights, and youth homelessness. Homeless San Diegans Ask Court to Stop Ticketing Vehicles

Homeless people in San Diego are fighting to stay in their RVs without being fined. The Law Center, Disability Rights California, and Fish & Richardson PC filed an injunction to stop ticketing and removing homeless people's vehicles during the class-action lawsuit *Bloom et al vs. City of San Diego*. In San Diego, "safe lots" do not allow RVs, and RV parks charge high rates that homeless people cannot afford. The current ticket policy in place also does not help homeless RV owners; if an owner does not pay their fines after receiving five tickets, their vehicle will be impounded. Advocates are hoping the court will approve and uphold the injunction while the suit is still taking place.

HerStory Ensemble and the Delaware Art Museum Social Justice Themed Exhibits

The Delaware Art Museum invited HerStory Ensemble to be one of several community participants to link current day issues including the lack of affordable housing, racial inequality and homelessness, the criminalization of homelessness, and advocacy for homeless legislation to three civil rights themed exhibits focused on racial and social justice as a call for action. Their calls to action will be displayed on cards on a wall labeled "Make Change" that visitors can take with them, and follow suggestions to take action on the issue of homelessness. The exhibit, which opened on June 30 and will run until September 9, is coordinated with the city-wide effort to mark the 50th anniversary of the powerful public response that followed the assassination of Dr. Martin Luther King Jr. HerStory Ensemble is an advocacy and empowerment community-based organization comprised of women experiencing homelessness, who are formerly homeless, or at risk of homelessness. In Sacramento, Judge Issues Preliminary Injunction against Panhandling Ordinance

U.S. District Court Judge England issued a preliminary injunction stopping the City of Sacramento from enforcing an expansive anti-solicitation ordinance because it violates people's First Amendment rights by restricting free speech. The lawsuit was filed by Legal Services of Northern CA and the ACLU Foundation of Northern CA on behalf of the Sacramento Regional Coalition to End Homelessness and James "Faygo" Clark.

Chicago Coalition for the Homeless Utilizing Illinois Bill of Rights for the Homeless Act

Earlier this year, the Chicago Coalition for the Homeless (CCH) successfully reached a settlement with the City of Chicago in a suit involving a homeless man whose possessions were thrown away by city sanitation crews. This was the first substantive case filed under the Illinois Bill of Rights for the Homeless

Act, which was enacted in 2013 under advocacy by the CCH. Since then, two more cases responding to the city's actions in Uptown and in the Lower Wacker area have been filed by the CCH based on the Homeless Bill of Rights. [Learn more about the work of the CCH.](#)
